Notice of Permit Application

The City of Burlington has received an application for a Conditional Use Permit (CUP) to construct a mixed-use development consisting of two three-story multiunit buildings containing 24 dwelling units each and one three-story mixed use building containing ten dwelling units and 1,902 square feet of ground-floor commercial space. The development will involve clearing, grading, and the installation of related improvements including landscaping, parking, utilities, and storm-water improvements. The project will be located at the intersection of South Goldenrod Road and West Stevens Road on parcels P23887 and P23886. Work will occur in a designated floodplain and will impact a wetland buffer associated with Gages Slough. Mitigation plans are included for wetland and floodplain impacts.

This project is subject to review and approval by the City of Burlington Hearing Examiner and requires a public hearing. The date of the hearing will be posted on the Community Development Department's website and distributed to any party who requests notification during the public comment period.

The City is utilizing the optional State Environmental Policy Act (SEPA) Determination of Non-Significance (DNS) process provided for in WAC 197-11-355 and expects to issue a MDNS. Additional mitigation measures may be required whether or not an EIS is required. Comments on the environmental im-
